## STATEMENT OF THE SOLICITOR GENERAL



I am pleased to present the Office of the Solicitor General's (OSG) 8th Bi-Annual Report, which covers the period from 1st July, 2021, to 31st December, 2021. This report exhibits the Office's commitment to excellence in carrying out its mandate of coordinating and handling civil and arbitral cases on behalf of the Government and its institutions.

I would like to take this opportunity to congratulate the Honorable Former Principal Judge, Dr. Eliezer Mbuki Feleshi for being appointed the Attorney General of the United Republic of Tanzania. We are confident that his experience, vigor, knowledge, humbleness, and jurist vision will steer the legal sector in the right direction at the same time provide valuable advice to the Government.

We also wish to extend our sincere gratitude to the 6th Phase Government for its support, and continued efforts in providing conducive environment for economic growth, industrialization, sustainable development, and better livelihoods for the citizenry. The OSG is committed to reciprocate these efforts while exercising its core mandate by effectively and efficiently handling cases instituted against and on behalf of the Government. Further, our engagement with stakeholders on a daily basis and the adoption of a dialogue approach in dispute resolution have proved to be cost effective and beneficial to all parties involved.

As of 31st December 2021, there were 4634 cases in the Civil Litigation Division of which 4619 were domestic civil cases and 15 were international civil cases. Out of 4619 domestic civil cases, 4005 cases were previously registered and 614 were new cases. All these Civil Cases handled covered different aspects of domestic and international litigation in matters relating to mining, contracts, health, tax, procurement, land, education, constitutional cases and human rights cases among others. During the same period, 105 arbitration cases were handled which covered various sectors including infrastructure, construction, communication, energy and mining among others. Out of 105 arbitration cases handled, 88 were previously registered and 17 were new cases.

During the reporting period, a total of 247 cases were concluded of which 240 were domestic civil cases, one (1) international civil cases, six (6) domestic arbitration proceedings. After conclusion of the said cases, the OSG saved Tshs. 191,619,472,237.19 from civil litigation cases and Tshs. 18,999,425,723.00 from arbitration cases, making a total of Tshs. 210,618,897,960.19 which would have become due for payment by the Government had it lost the said cases.

Notably, the OSG has been fully involved in handling disputes emanating from strategic projects such as ICC reference No. Exp/706 between S.G Engineering & Construction Corp. (South Korea) and the Tanzania National Road Agency (TANROADS) regarding the construction of Selander Tanzanite Bridge. The said dispute was settled amicably and thus paving way for final completion of the project which was inaugurated on 25th March 2022 by Her Excellency Samia Suluhu Hassan, the President of the United Republic of Tanzania. The report also shows a number of cases of a similar nature.

Our many achievements are the result of an uncompromising commitment to excellence, professionalism, creativity, and innovation of our staff. In the pages that follow, you will see why that faith is justified. We can proudly, say that we are not yet there but we have increased our efforts, accountability and patriotism in fulfilling our responsibilities to ensure that the goals of the National Development Vision 2025 are achieved. Let the work continue.

## STATEMENT OF THE DEPUTY SOLICITOR GENERAL



**O**n behalf of the Office of Solicitor General (OSG) family, we are pleased to present the 8th Bi-annual Report covering the period from 1st July- 31st December, 2021. During this period, the OSG has continued to discharge its mandate of coordinating and representing the Government and its institution in all civil and arbitration cases instituted for or against the Government. This has been made possible through, among other things, the increase of the OSG budget from Shillings 11,482,048,000.00 in the financial year 2020/2021 to Shillings 12,131,347,000.00 in 2021/2022.

As a public law office, we believe that in order to execute our mission and vision properly, we need to invest in both human capital and skills development. To achieve this objective, OSG has continued to improve the working environment for its staff as a whole including making available working tools such as computers, printers and purchased 13 new vehicles which are now awaiting delivery. Further to that, the OSG has recruited drivers, personal secretaries and state attorneys, making a total of 175 staff and sponsored 123 staffs in short and long-term training. During the same period, we obtained Government approval to commence construction of our Head Offices at “Government City”, Mtumba Dodoma. In that regard, we engaged Tanzania Building Agency (TBA) as a consultant.

The OSG has continued to improve its case management systems specifically the Case Management Inventory Systems (CIMS) and continued to work closely with the Judiciary towards the integration of a Judicial–OSG information sharing system. The OSG is also currently working towards establishing a well- maintained case law database and strengthening our library referencing system. Further, we are proud to have passed our most current Client Service Charter, Quality Assurance Manual and Practice Directions which are now operational.

At this juncture, allow me to congratulate and thank the staff and management of the OSG for their resilience, patience, cooperation, hard work and dedication in discharging the mandate of the OSG. I look forward to seeing more innovative and

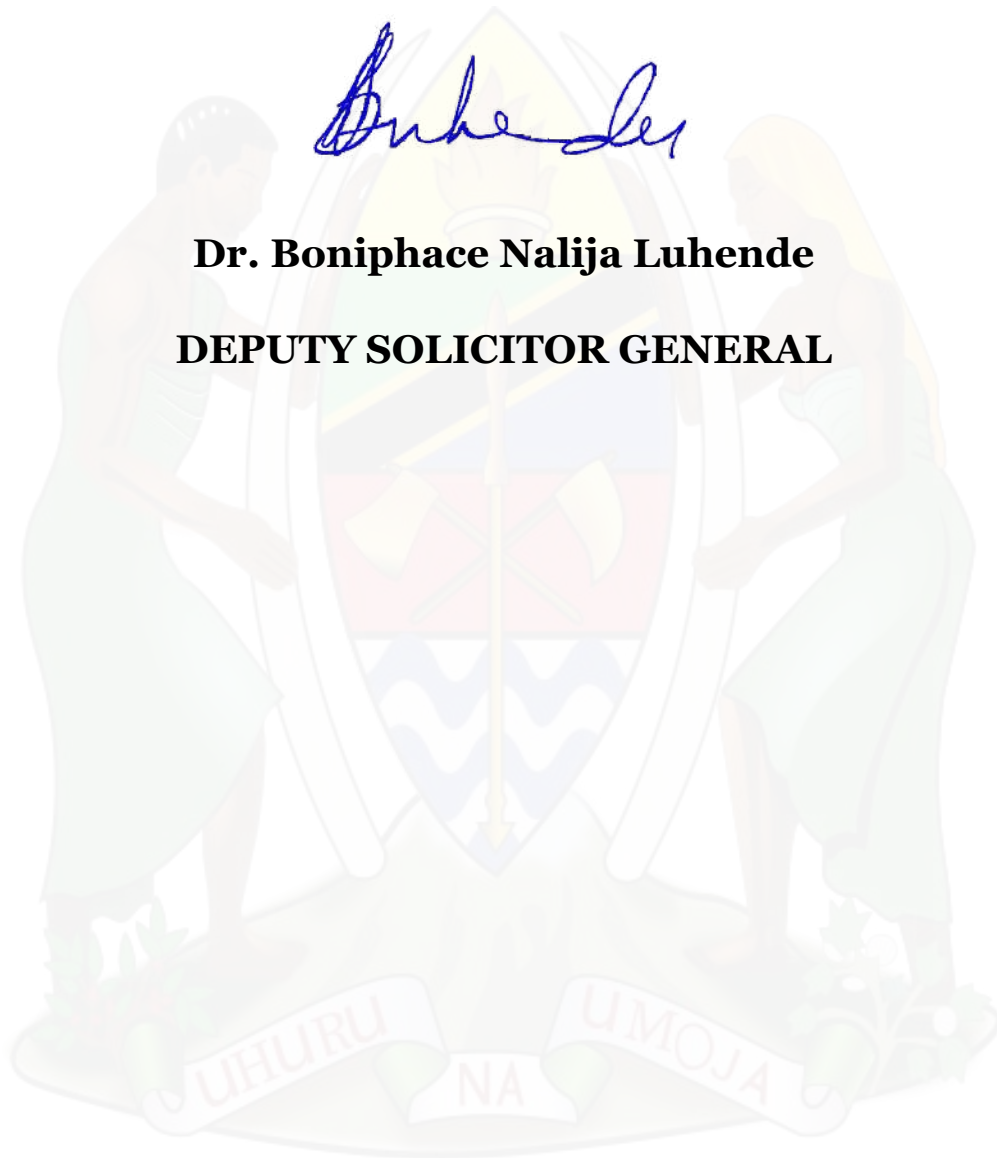
progressive projects over the next years.

## EXECUTIVE SUMMARY

The Office of Solicitor General (OSG) was established by the Office of the Solicitor General (Establishment) Order, G.N. No. 50 of 2018 as gazetted in the Government Gazette No. 3 Vol. 99 dated 13 February 2018. The main objectives for establishment of OSG are to enhance and strengthen the Government ability to litigate civil cases including human rights, constitutional matters and election petitions in courts of law, and undertake arbitral proceedings in both domestic and international tribunals.

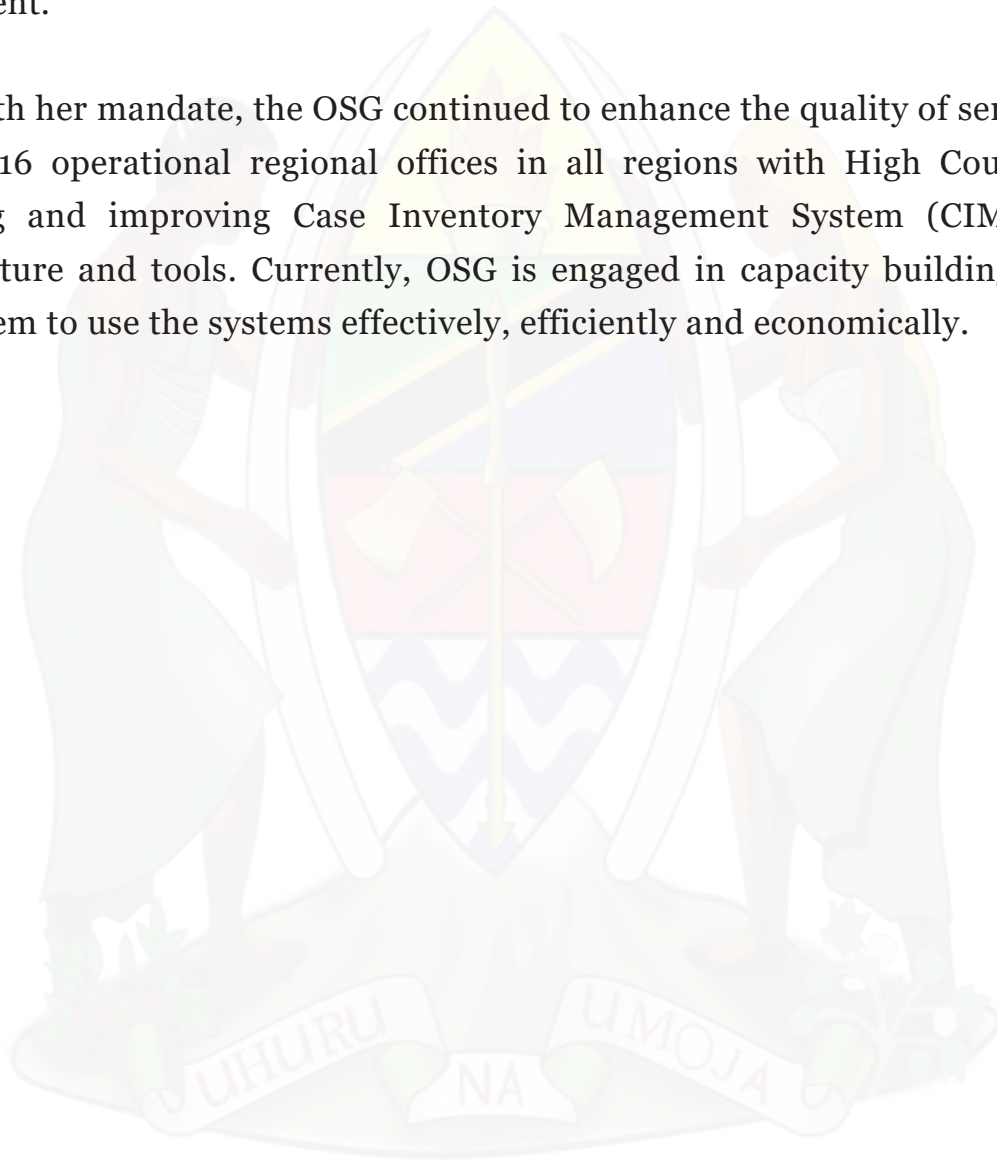
In discharge of its statutory duties, the OSG takes and conducts civil litigation and arbitration on behalf of the government and its institutions. Thus, the OSG prepares, institutes and defends suits, claims in subordinate courts, the High Court, the Court of Appeal and domestic and international arbitral tribunals in that behalf. The OSG also coordinates all civil litigation and arbitral proceedings in the courts of law and arbitral tribunals on matters to which the central-government, independent department executive agency, or local government is a party or has interest. In discharge of this coordination role, OSG has mandate to give directives and instructions to law officers, state attorneys and legal officers who conduct civil litigation or arbitration proceedings.

This Bi-Annual Report has been prepared pursuant to clause 4(1)(g) of the Office of the Solicitor General (Establishment) Order, GN No. 50 of 2018, which require OSG to prepare and submit bi-annual report to the Minister responsible for Constitutional and Legal Affairs on matters and duties carried in the discharge of its functions bi-annually. The Report highlights activities that were carried out including cases that the OSG has conducted or participated both locally and internationally from 1st July 2021 to 31st December 2021. The report also identifies major achievements, challenges, methods used to mitigate the challenges and recommendations to assist the office in effectively attaining its entrusted mandates.

During the reporting period, a total of 631 cases were registered of which 614 were Civil cases and 17 arbitration cases. Out of the 631 cases, there were 610 domestic civil cases, four (4) international cases, and 17 domestic arbitration cases. A total of 247 cases were concluded in the reporting period, of which 240 were domestic civil cases, one (1) international civil case, and six (6) domestic arbitration proceedings. Further, the OSG saved Tshs. 191,619,472,237.19 after the conclusion of the said civil litigation cases and Tshs 18,999,425,723 after the conclusion of the said civil litigation cases and Tshs.

18,999,425,723.00 after the conclusion of the said arbitration cases making a total of Tshs. 210,618,897,960.19. In carrying out the general coordination of Civil and Arbitral matters, the OSG has effectively handled notices of intent to sue the Government, held various pre- suit meetings, encouraged prior consultation with various Government institutions and Agencies before making litigation decisions and facilitated various out of court settlements. All of these activities were undertaken for the sole purpose of effective management of cases and reducing number of unnecessary suits against the Government.

In line with her mandate, the OSG continued to enhance the quality of services offered through, 16 operational regional offices in all regions with High Court registries, upgrading and improving Case Inventory Management System (CIMS) and ICT infrastructure and tools. Currently, OSG is engaged in capacity building of staffs to enable them to use the systems effectively, efficiently and economically.

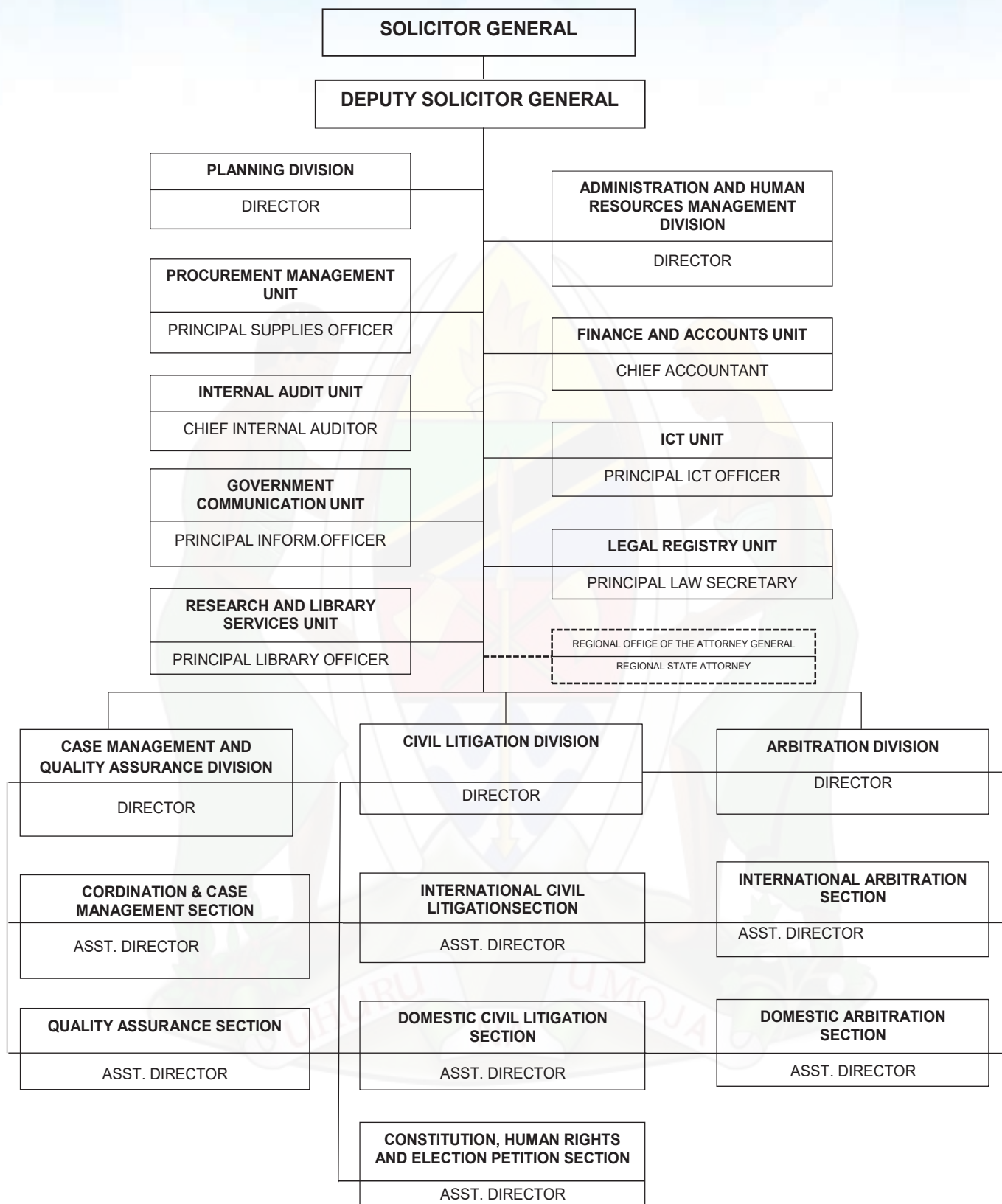
The report also reflects on the achievements and challenges faced by the OSG during the reporting period and how the same were mitigated.

## 1.1 ESTABLISHMENT OF THE OFFICE OF THE SOLICITOR GENERAL

### Establishment

The OSG was established by the President of the United Republic of Tanzania, under the powers vested in him by Article 36(1) of the Constitution of the United Republic of Tanzania, 1977. The Office of the Solicitor-General (Establishment) Order (GN. No. 50/2018) which established the OSG was gazetted in the Gazette of the United Republic of Tanzania No. 3 Vol. 99 dated 13th February 2018.

On 15th April 2018, Dr. Julius Clement Mashamba was appointed the Solicitor General and Dr. Ally Possi the Deputy Solicitor General (who were sworn-in to Office on 20th April 2018), and on 20th September 2019 Mr. Gabriel P. Malata was appointed the Deputy Solicitor General and later on 10th July 2020 Mr. Malata was appointed the Solicitor General and Dr. Boniphace Naliya Luhende the Deputy Solicitor General.

## 1.2 OBJECTIVES

During the reporting period, the OSG, in addition to the objectives set out in Paragraph 3 of G.N. No. 50/2018, was guided by six key objectives, which are categorized into two groups namely national cross-cutting objectives and strategic objectives as follows:

- a. National crosscutting objectives (implemented) by all MDAs) are:
  - i. Non-communicable diseases, HIV and AIDS infections reduced and Supportive Services Improved; and
  - ii. Implementation of National Anti-Corruption Strategy Enhanced and Corruption incidences reduced.
- b. Strategic objectives (implemented by all Divisions and Units) which reflect core functions of the Organization) are:
  - i. Quality representation in civil litigation and Arbitration to the Government and its Institutions strengthened;
  - ii. Effective case Management and Quality assurance systems enhanced;
  - iii. Administrative support and Institutional Capacity Strengthened; and
  - iv. Financial Management and accountability improved.

## 1.3 FUNCTIONS

The major undertaking of the OSG is litigation on behalf and for the Government of the United Republic of Tanzania and all its institutions or any private entity in which the Government holds substantial interest. The Office deals mainly with arbitration and civil litigation (both local and international). Civil litigation includes human rights cases, constitutional matters, as well as election petitions. Specifically, pursuant to Paragraph 4(1) of G.N. No. 50/2018, the main functions of the OSG are:

- a. To take and conduct civil litigation and arbitration on behalf of the Government and for that purpose, to direct Law Officers, State Attorneys and Legal Officers who conduct civil litigation or arbitration proceedings;
- b. To coordinate civil litigation in courts of law and arbitral tribunals on matters to which the Central Government, independent department executive agency or local government are parties or have interest;
- c. To prepare and institute suits, claims in subordinate courts, the High Court, the Court of Appeal and arbitral tribunals in that behalf;
- d. To carry out the general supervision of Law Officers, State Attorneys and other officers or staff appointed, employed or designated for the Office of the Solicitor-General;
- e. To administer legal functions performed by Law Officers, State Attorneys and other Officers or staff of the Office of the Solicitor General;
- f. To summon any public officer to give explanation, or information regarding any matter which is or likely to be the subject of civil litigation or arbitration;
- g. To prepare and submit bi-annual report to the Minister responsible for constitutional and legal affairs and a copy to the Attorney-General on matters and duties discharged of functions performed by the Office of the Solicitor-General;

- h. To intervene and take over at any stage civil proceedings, appeal, execution or any incidental proceedings before any court of law or arbitral tribunal in which the Central Government, independent departments, agencies or local government authority have interest;
- i. To issue directives to any public officer performing functions relating to civil litigation in courts of law or arbitral tribunals; and
- j. To appoint or employ and discipline Law Officers, State Attorneys and other officers or staff of the Office of the Solicitor-General.

## 2.0 REPORTING OBLIGATION

The OSG is obliged, under paragraph 4(1) (g) of G.N. No. 50/2018, to prepare and submit Bi- Annual Report to the Minister responsible for Constitutional and Legal Affairs<sup>1</sup> on matters and duties carried in the discharge of its functions during the reporting period. Therefore, this Bi-Annual report is prepared in compliance with this reporting obligation.

### 2.1 BI-ANNUAL REPORT (JULY - DECEMBER 2021)

#### 2.1.1 OVERVIEW OF THE REPORT

The report covers activities carried out by the OSG including handling cases on arbitration and civil litigation. The report highlights the implementation of annual plans and budgets for the period under review.

The activities carried out were premised around the following broad areas of civil litigation and arbitration:

- A. Civil litigation: this section highlights the conduct of civil cases in both international and domestic courts/tribunals. They include Constitutional, election petition and human rights litigation. These cases were conducted in two areas of litigation:-
  - i. Domestic civil litigation of cases (Claims against the Government) in the Commission for Mediation and Arbitration (CMA), District Land and Housing Tribunals, Quasi-judicial bodies, District and Resident Magistrate Courts, High Court and Court of Appeal.
  - ii. International Civil litigation conducted
    - Civil litigation conducted in foreign National Courts;
  - iii. Human Rights, Constitutional and Election Petitions Conducted.
    - a. Human rights cases litigated in the African Court of Human and Peoples' Rights (AfCHPR);
    - b. The East African Court of Justice (EACJ) on the Interpretation and Application of the Treaty for the Establishment of the East African Community.

- B. Arbitration: this section highlights arbitration cases conducted in both international and domestic arbitral Tribunals. The report also highlights some preliminary activities carried out in respect of supervision, monitoring and evaluation of civil litigation and arbitration in the period between July to December, 2021.
- C. Staff recruiting and maintenance.
- D. Financial matters including planning and budgeting.
- E. Internal Auditing and checks and balances

## 2.1.2 SPECIFIC ACTIVITY REPORTS OF DIVISIONS AND UNITS OF THE OSG DEPARTMENTS

### 1. PLANNING DIVISION

- A. Performance of Bi - Annual plans and budgets

The performance of Bi – Annual plans and budgets were as follows:

- i. Annual approved budget for the financial year 2021/22

The approved budget for the Financial Year 2021/2022 was Tshs. 12,131,347,000 out of which Tshs. 2,658,329,000 were for personal emoluments and Tshs. 9,473,018,000 were for other charges (OC). Out of OC's budget, Tshs. 1,743,500,000 were protected for the purpose of international cases and Tshs. 7,729,518,000 were for office operations including handling of domestic cases. Table showing. ## ii. Released amount and Expenditure for the period

During the period under review, the total amount released was Tshs. 7,272,760,427.63 out of which Tshs. 1,655,083,808 was for Personal Emoluments and Tshs 5,617,332,499.98 was for Other Charges (OC).

The total amount spent was Tshs. 6,100,791,971.82 which is 88.9 percent of the amount released. Out of the amount spent, Tshs. 4,445,608,164.62 was spent on Other Charges (OC) and Tshs. 1,655,083,808 was spent on Personal Emoluments.

## B. Coordination, Supervision and Monitoring of plans and budget and their implementation

During the period, the OSG strived to ensure that all activities related to planning and budgeting as well as Monitoring and Evaluation were properly handled. Among others, the OSG coordinated the implementation of budget for the financial year 2021/2022. The OSG also coordinated Monitoring and Evaluation activities in eight (8) regional Offices including Mtwara, Songea, Iringa, Mbeya, Tanga, Moshi, Arusha and Dodoma in order to evaluate the performance of OSG regional offices, highlight the challenges and possible solutions.



## 2. CIVIL LITIGATION DIVISION

As of 31st December 2021, there were 4634 cases in the Civil Litigation Division of which 4619 were domestic civil cases and 15 were international civil cases. Out of 4619 domestic civil cases, 4005 cases were previously registered and 614 were new cases that were received and registered during the reporting period.

During the reporting period, 231 domestic cases were concluded. The remaining cases are at different stages. Further, the OSG saved Tshs. 191,619,472,237.19 from the concluded cases.

In enhancing our participation in international forum, the OSG had the opportunity of participating in a conference which was organized by the African Court on Human and Peoples' Rights. The conference was held at Julius Nyerere Convention Center in Dar es Salaam from the 1st to 3rd November 2021. Our office had the opportunity to present on the implementation of the African Court decisions in Tanzania.

## 3. ARBITRATION DIVISION

During the reporting period, the OSG handled a total of 105 arbitration cases of which 79 were domestic arbitration cases and 26 were international arbitration cases. Out of 105 arbitration cases handled, 88 were previously registered and 17 were new cases.

During the reporting period, six (6) domestic arbitration cases were concluded. Out these concluded cases, the OSG saved USD 1,333,750 and Tshs. 3,067,625,000.00 which in total amounts to Tshs. 18,999,425,723.00.

## 4. CASE MANAGEMENT AND QUALITY ASSURANCE DIVISION

### a. Coordination, Supervision and Monitoring of Civil Litigation and Arbitration

The Case Management and Quality Assurance Division has continued to coordinate and supervise the quality standards set by the OSG and provide a link between the OSG and other Government institutions representing interests of the Government in judicial or quasi-judicial bodies. The aim is to provide effective case management and quality assurance of the services provided to the Government and its institutions

More efforts have been put on case analysis, legal research, and publications with a view to identify and analyze types of cases against the Government and Public institutions by looking at their complexity, sensitivity, adversity

and volume of such cases with the view of clustering them and devising both response and preventive strategies. This also included identifying public institutions facing litigation and arbitration proceedings and developing the intervention strategies and approaches which include early request for information and meetings at the notice to institute legal proceedings stage, discussion on possible settlement and bipartisan meetings and discussions with the adverse party (s). Notably, this is an on-going undertaking. But, to continue with this momentum, for the reporting period, the OSG started to consult with Ministries and Government Institutions and requested them to submit to OSG comprehensive lists of pending cases and their respective status.

Currently, the OSG maintains a register of all institutions' cases which makes it easy to follow up and intervene whenever needs arise. Monitoring of government cases has not only reduced unnecessary losses but it has also significantly reduced the risk of mishandling of important government information being divulged to unintended parties.

b. Quality Assurance

The OSG strives to ensure quality services is provided to the Government and its Institutions. To provide quality services to its stakeholders, the OSG has ensured that all notices of intention to sue the Government are communicated to the Ministry or Government Institution in a timely manner and early preparations are done by involving the relevant stakeholder.

Quality assurance standards and practice directions have been prepared and approved by the Management. By virtue of Paragraph 5(6) of the Solicitor General (Establishment) Order, the Solicitor General has further continued to appoint and designate state attorneys to perform the functions or exercise powers of the Solicitor General by issuing instruments.

The OSG has further prepared a checklist which is an aid to facilitate inspection of our attorneys when representing the Government in court. The Checklist covers many aspects such as cross-checking items, list things to be done, and points to be considered before, during and after litigation, so as to asses a fair view of our compliance level to court practices and procedures.

## 5. ADMINISTRATION AND HUMAN RESOURCE MANAGEMENT DIVISION

### a. Administrative Support and Institutional Capacity

During the reporting period, OSG continued to focus on administrative support and institutional capacity issues for staff which includes increasing number of staff, capacity building, improving working facilities and infrastructure.

### b. Staffing

The required OSG number of staff is 312. The OSG continued to recruit and deploy the required personnel to enable it to properly perform its mandate. Currently, OSG has a total of 150 employees of which 91 are State Attorneys, 11 Law Secretaries, and 48 other staff.

Irrespective of having filled some vacancies, the OSG still has shortage of 162 staff. The office has continued to work with the President's Office, Public Service Recruitment Secretariate to recruit new staff or transfer competent staff from other government institutions to the OSG.

### c. Capacity building

The OSG continued to build capacity for its staff and during the reporting period, 123 staff attended both short-term and long-term training.

### d. Improvement of Working Environment and Facilities

The OSG continues with her endeavor to digitalize and modernize the office by renovating Dar es Salaam and regional offices, modernizing both the legal registry and library, procuring working tools such as office consumables, computer supplies, and accessories, printers and scanners, as well as the procurement of thirteen vehicles, repair and service of motor vehicles.

### e. Improvement of Working Infrastructures

During the reporting period, the OSG continued to improve physical electronic infrastructures and systems including Case Inventory Management System (CIMS) to enhance the quality of services and manage cases effectively and efficiently. Digital record-keeping has been

improved to decrease paperwork, while centralized data management allows for remote access. Similarly, the OSG has been connected to e-office system and government mailing that improves communications through electronic networking. So far the OSG has 17 established offices in all regions with High Court Registry including the Capital City of Dodoma.

## **6. FINANCE AND ACCOUNTS UNIT**

The OSG is responsible to provide financial management reports, prepare payments, statutory deductions, employee's contribution payroll management and other related financial functions.

During the reporting period, the OSG continued to ensure that financial management and accountability is improved and administrative, welfare and financial services are provided to staff timely. The Unit has finalized the audit cycle for the year 2020/2021 and submitted the report to the Controller and Auditor General (CAG). Further, the OSG has prepared necessary documents required for the preparation of Financial Reports and aligned Statements for the year 2021/2022.

During the same period, the OSG facilitated various payments related to its operation, conducted Stock taking and updated the Fixed Asset Register to meet quality accounting standards.

## **7. LIBRARY AND RESEARCH UNIT**

The Library and Research Unit (LRU) is responsible to provide legal research in civil litigation and arbitration matters, publication, and library services.

During the reporting period, the OSG did the following;

- a. Provided Reference and Circulation of library services.
- b. Compiled and bound 60 Principal and 60 Subsidiary legislation.
- c. Digitized and disseminated 40 compiled statutes and various cases to State Attorneys electronically.
- d. Indexing of 60 Acts Supplement Amendments from 2020 to 2021.

## 8. LEGAL REGISTRY UNIT

The LRU is responsible to provide services in collecting, documenting and keeping under custody legal documents.

During the reporting period, the Unit performed the following activities:

- i. Registered a total of 631 cases and maintained the register of civil and arbitration matters filed by or against the Government;
- ii. Record all civil and matters from judicial, tribunals and quasi-judicial bodies which the Government is a party;
- iii. Serve documents relating to civil and arbitral matters involving the Government;
- iv. Maintain files for cases involving the Government; and
- v. Prepare and maintain a register of all communications from the public on civil and arbitral matters by or against the Government.

During the reporting period, the OSG has continued to ensure that case files are readily available for court proceedings, registered cases received from various Ministries and Government Institutions, participated in the preparation of the OSG risk register, carried out stocktaking of pending and completed cases in the CIMS, registered pleadings in the Judiciary system (JSDS2) and carried out service of various court documents and proceedings from the OSG.

## 9. PROCUREMENT UNIT

The Procurement Unit is responsible to provide expertise and services in procurement, storage and supply of goods and services according to Procurement laws, regulations, guidelines and other directives.

During the reporting period, the OSG implemented the first half of the annual Procurement Plan for financial year 2021/2022. In the said plan, the OSG had planned to procure items with estimated amount of Tshs. 3,970,735,099. The performance of the plan was quite favorable since in the first half of the plan, the OSG managed to procure items amounting to Tshs. 1,807,371,518 which is equivalent to Forty-Six percent out of Fifty Percent.

The Unit coordinated and managed the procurement of various items such as kitchen equipment, staff uniforms, food and refreshment, motor vehicles and motor vehicle accessories, curtains, ICT equipment and software.

**10. INFORMATION AND COMMUNICATION TECHNOLOGY UNIT**

The ICTU is responsible for provision expertise on Information Communication Technology Systems and Services to the office.

During the reporting period, the OSG performed the following activities: -

- i. Facilitated modernization of the office with high technology equipment such as a new server with the ability of storing data and case files;
- ii. Collaborate with e-Government Authority to undertake OSG system (CIMS) improvement;
- iii. Facilitate OSG staff on access and proper use of Government systems;
- iv. Supervise Maintenance of ICT system and infrastructure; and
- v. Coordinate Acquisition of ICT devices, installation and distribution to staff.

**11. GOVERNMENT COMMUNICATION UNIT**

The Government Communication Unit is tasked to provide and disseminate information to the public and other stakeholders, including creating awareness on OSG activities. During the reporting period, the Unit managed to perform the following activities: -

- i. Applied and received official license of the OSG Official Magazine (Jarida la Wakili Mkuu);
- ii. Prepared and published the second edition of OSG official magazine (Jarida la Wakili Mkuu);
- iii. Prepared and published OSG Communication Guidelines;
- iv. Managed OSG events and protocol activities;
- v. Improved and updated OSG website and social media timely;
- vi. Prepared and published press releases, news stories and feature article for the press;
- vii. Disseminated OSG information through different media channels;
- viii. Facilitated training for OSG Core Departments on Communication;
- ix. Respond to media enquiries from different media houses;
- x. Monitoring and evaluation of all OSG information appearing in the mainstream and social media public domains; and
- xi. Prepared several publicity materials, merchandised items, and promotional materials.

## 12. INTERNAL AUDIT UNIT

The OSG Internal Audit Unit is responsible for conducting audit and providing advisory services in the management of resources.

During the reporting period, the Unit carried out the following activities; -

1. Preparation and Facilitation of the first and second Quarter audit committee meeting;
2. Audit of regional offices;
3. Audit of expenditure management in Accounts and Finance Unit;
4. Audit on Technical support and maintenance of Information Technology Unit Conducting Procurement Planning audit;
5. Conducting Fuel Consumption Management audit;
6. Audit on Budget Implementation and Control;
7. Preparation of first and second quarterly internal audit reports; and
8. Follow up on implementation of audit recommendations as issued by Chief Internal Auditor and Controller and Auditor General (CAG).

### 3.0 MAJOR ACHIEVEMENTS

In the discharge of its functions, the OSG has achieved several milestones, including:-

- i. Successfully represented the Government and public institutions in a total of 4739 civil cases and arbitration proceedings and saved Tshs. 210,618,897,960.19 which would have become due for payment by the Government had it lost the said cases;
- ii. Facilitated the participation of staff in long term and short term training, various local and international conferences and workshops for purpose of capacity building;
- iii. Conducted, facilitated and participated in various amicable settlement negotiation in matters involving the Government and other private institutions or individuals and in matters between Government institutions;
- iv. Preparation and passing of Practice Direction (Arbitral and Litigation matters) (, Quality Assurance Manual, Client Service Charter, and OSG Communication Guidelines);
- v. Improved Case Inventory Management System (CIMS);
- vi. Conducted Law review and recommended for amendments to various civil legislations;
- vii. Conduct performance and technical meetings which have led to improvement of our litigation performance;
- viii. Successfully improved the office library by ensuring that the library is well furnished with the required furniture and relevant and required books;
- ix. Obtained and deployed additional staff to fill in vacancy position;
- x. Successfully improved the working environment by renovating the office building and procuring working facilities and tools such as video conference system, stationeries, tonner, printers, scanners, laptop computers, desktop computers;
- xi. Prepared a risk register to be launched in September, 2022;
- xii. Successfully operationalized 16 regional offices in all High Court registries; and
- xiii. Accomplished the preparation of financial statements and submitted to the Controller and Auditor General on time.



## 4.0 CHALLENGES

The above pointed success of the Office glimpses on the possibilities of overcoming some of the challenges stated in this section. The following are major challenges identified in implementing the functions of the OSG.

a. Budget ceiling limitation

The allocated budget is minimum compared to the range duties and responsibilities vested on the OSG.

b. Insufficient number of staff

The OSG staffing level required during the period under review was at least 312 staff. However, currently the OSG had only 150 staff. Irrespective of having filled some vacancies, the OSG still has a shortage of 162 staff.

c. Insufficient number of specialized skilled staff

The OSG has insufficient number of staffs with specialized skills in dispute prone areas like Oil and gas, Investment law, Construction Contracts, aviations, maritime law, and international negotiation skills.

d. Lack of own office buildings

To effectively perform its duties, the OSG needs to have its own office buildings in Dar es Salaam, Dodoma and in other regions where operations take place. The OSG is currently using the building owned by other government entities and rented office spaces.

e. Inadequate mechanisms to retain staff (Retention Scheme)

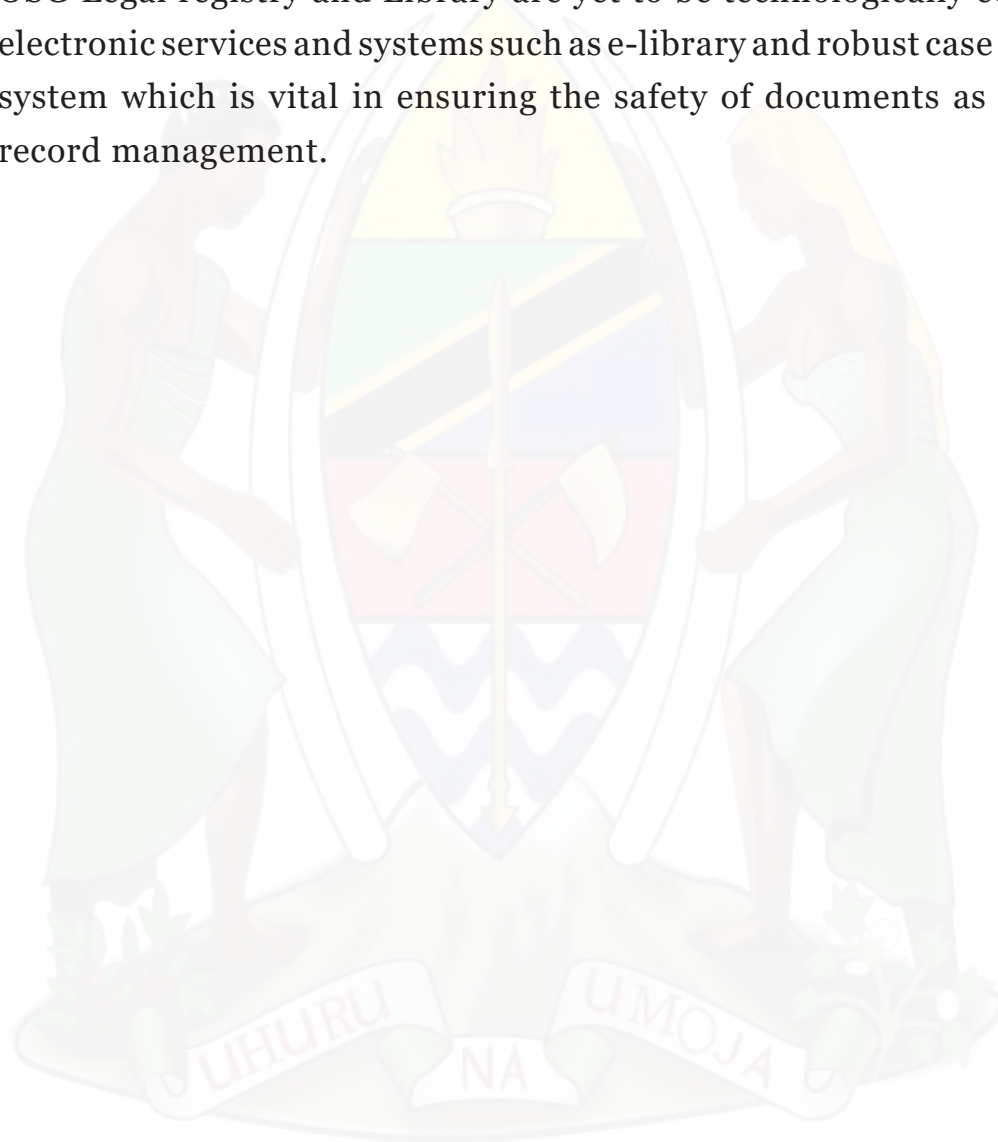
The current remuneration is less favorable compared to other office of similar nature. This situation increases temptation to staff to look for better offer in the market where they can be well rewarded.

f. Shortage of Motor Vehicles

To perform its duties efficiently and effectively, the OSG requires at least 35 motor vehicles. Conversely, during the reporting period the office had only 18 motor vehicles and 2motorcycles. There is still shortage of 17 motor vehicles.

g. Shortage of electronic services in Legal Registry and Library

OSG Legal registry and Library are yet to be technologically equipped with electronic services and systems such as e-library and robust case management system which is vital in ensuring the safety of documents as well as easy record management.



## 5.0 FACTORS TO MITIGATE THE CHALLENGES

The management of the OSG have taken and will continue to take several measures to mitigate the various challenges that they face, which include ; -

- a. On-going discussions with the Government and various stakeholders including the Ministry of Finance and Planning and development partners to secure development budget;
- b. Liaising with the Office of the President, Public Service Management and Good Governance to obtain staff recruitment approvals;
- c. Liaising with the responsible authorities to ensure that it owns offices at Government Headquarters in Dodoma as well as Regional Offices. The has been permitted to start building its Head Office at Mtumba Government City in Dodoma;
- d. To continue allocating funds for the purchase of vehicles, whereas in the Financial Year 2021/22 the Office allocated a budget for the purchase of 13 vehicles;
- e. Continue to improve the working environment with a view of motivating employees and provide incentives to bost morale;
- f. Continue to improve relations with the Government, public entities, and Institutions that we represent in various forums to have a more effective partnerships; and
- g. Continued to allocate funds from the regular Budget for the purchase of various Office facilities and working equipments.

## 6.0 RECOMMENDATIONS

### 6.1. GENERAL RECOMMENDATIONS

As a general recommendation, the OSG urges the Government to continue supporting the OSG and speed-up empowerment and retooling of the Office with both human, material and financial resources.

### 6.2. SPECIFIC RECOMMENDATIONS

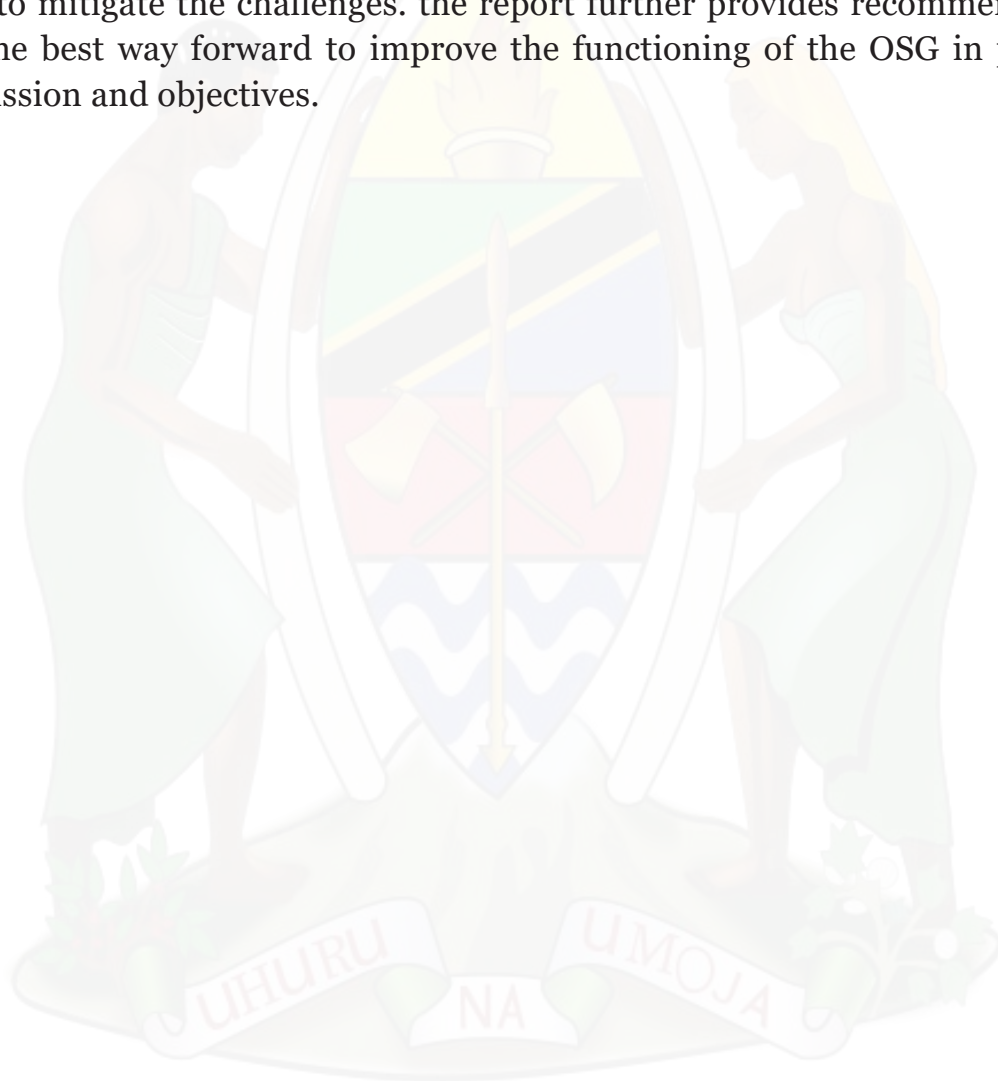
Specifically, it is recommended as follows:

- i. The current reforms in the OSG, Office of the Attorney General and National Prosecutions Services Office should be closely linked with the other Legal Sector Reforms including on-going reforms in the Judiciary. This will enable the OSG and other affiliated institutions to march in same direction envisaged by the Government;
- ii. To enable the OSG to effectively monitor all litigation and arbitral disputes. To make this possible, it is recommended that all MDAs should adhere to all specific and general instructions and guidelines issued by the Attorney General and Solicitor General with regards to civil Litigation and Arbitration proceedings.
- iii. Provision of special funds to the OSG for the purpose of facilitating Trainings and acquisition of ICT equipments.

## 7.0 CONCLUSION

This Bi-Annual Report has been prepared pursuant to the provisions of, paragraph 4(1)(g) of the Office of the Solicitor General (Establishment) Order, GN No. 50 of 2018, Articles 59 and 59A of the Constitution of the United Republic of Tanzania (1977) and the Office of the Attorney-General (Discharge of Duties) Act (2005) as amended from time to time.

The report has highlighted activities carried out and cases handled by the OSG during the reporting period. The report has also highlighted achievements and challenges the OSG has faced in the reporting period and it has recommended some measures that need to be taken to mitigate the challenges. The report further provides recommendations that suggest the best way forward to improve the functioning of the OSG in pursuit of its vision, mission and objectives.
